From the Palm Beach TPA Public Participation Plan:







Technical Advisory Committee (TAC)

- West Palm Beach Representatives dissented due to the inclusion of funding for the State Road (SR) 7 extension.

Citizen's Advisory Committee (CAC)

Recommended Adoption Unanimously

Vision Zero Advisory Committee (VZAC)

- Recommended Adoption 12-2
- West Palm Beach Representatives dissented due to the inclusion of SR-7 extension. The Disabled Community Representative dissented due to concerns with shared use paths.
