Matthew stated the FY 23-24 UPWP is the 2-year business plan and budget for the agency covering a period of July 1, 2022 to June 30, 2024. The UPWP serves as the TPA's application for federal planning funds and includes a description of the planning work, deliverables, timeframes, and source and amount of funding requested. The UPWP also includes federal and state review comments that will be incorporated into the final version for Governing Board adoption scheduled for May 19, 2022.
